City of Leoti Governing Body met in regular session April 18, 2022 at 6:30 p.m., at the City Hall Meeting Room.

Mayor Charlie Hughes called the meeting to order at 6:30 p.m.

Mayor Hughes asked City Clerk Jeannine Hassell for Roll Call; Councilors Kelma Burch, Tammie Meyer-Givens, Derek Meyer, City Attorney Becky Faurot, City Superintendent Travis Seaton and Code Enforcer Adam Marcotte. Also present were Bryce Nickelson, Vic Case, Lynda Goodrich and Kris Casper. Council President Greg Graff and Councilor Tyrrell Tankersley were absent.

City Clerk Jeannine Hassell reported the first ARPA (American Rescue Plan Act) report is due on April 30, 2022. Hassell also shared that KDOT will start taking bids for the Highway 96 project in May and should have a contractor in place by the fall. The start of the project will depend on the contractor with March 2023 being the latest date.
