The governing body found the structure located on the said property unsafe and dangerous. Additionally, the owner of such structure is directed to commence removal or repair the pre-fabricated storage shed and tool shed located on the East and North side of the lots. Crouch moved, Hughes seconded to recommend bringing forth a resolution at the next City Council meeting for the abatement of the property after a 90 day period. Motion carried unanimously.

The governing body found the structure located on said property unsafe and dangerous. Crouch moved, Hughes seconded to recommend bringing forth a resolution at the next City Council meeting for the abatement of the property after a 90 day period. Motion carried unanimously.

Elder moved, Burch seconded to recommend bringing forth a resolution at the next City Council meeting for the abatement of the property after a 90 day period. Motion carried unanimously.
