City Superintendent Travis Seaton reported the city crew has been locating and preparing manholes for Mayer Specialty Service sewer maintenance. Seaton spent the day with EMC Insurance claims adjuster looking at City of Leoti property that was damaged from the hail storm. Discussion was held on handheld and stationary radios.
