Motion carried unanimously. Meeting resumed at 7:42 p.m. Mayor Green declared no action taken.

Baker moved, Farr seconded to approve Ordinance 2017-03 – Solicitor, Peddler, Transient Merchant Amendment. Motion carried unanimously.

Porter moved, Baker seconded to approve Charter Ordinance 2017-02 – Court Costs. Motion carried unanimously.

Mayor Green presented entity budgets that have been submitted for 2018. Price moved to approve all entity budgets as requested. Motion died due to lack of a second. Price moved, Porter seconded to approve \$6,000 for Wichita County Historical Society. Motion carried unanimously. Porter moved, Baker seconded to approve \$42,750 for Wichita County Economic Development. Motion carried unanimously. Price moved, Porter seconded to approve \$22,500 for Wichita County Parks and Recreation. Mayor Green called role: Roelfs, yea; Price, yea; Porter, yea; Baker, nay; Farr, yea. Motion carried 4:1.

Baker moved, Farr seconded for adjournment at 8:52 p.m. Motion carried unanimously.
