City Superintendent Travis Seaton reported well sixteen was causing the cloudy water. Adjustments were made and a vent valve was replaced. City Clerk Hassell reported the city has only received one hundred lead and copper surveys from the community. City Hall office has asked for council to help remind the community to turn them back in filled out to the best of their knowledge. City Hall has received lots of compliments on the veteran banners.
